### **Fishing Classes** of ANSA Qld for records and competition

There are different divisions that are determined by gender and age at 1<sup>st</sup> July

- Sub Junior Male and Female – aged under 10 years

**New members joining after 1st January** are eligible for half year fees.

If a new member joins after 1st April and pays a **full annual** fee, their membership will carry through to 30th June the following year.
